## ORDER STRIKING EXHIBITS FROM PREARBITRATION MEMORANDUM

On September 20, 2016, the parties in this case entered into a Joint Stipulation wherein the parties agreed to a binding arbitration before a three-judge panel consisting of the Honorable Christopher C.
