**SUPPLEMENTAL AMENDMENT TO JOINT STIPULATION AND ORDER TO STAY
ACTION AND SUBMIT TO BINDING ARBITRATION**

WHEREAS, Plaintiffs The West Virginia Investment Management Board and The Consolidated Public Retirement Board ("Plaintiffs"), and Defendant The Variable Annuity Life Insurance Company ("VALIC" or "Defendant") (collectively, "the parties") entered into a prior Joint Stipulation and Order To Stay Action and Submit to Binding Arbitration on September 20, 2016 ("Joint Stipulation"), and the Court so ordered the Joint Stipulation on the same date;

WHEREAS, pursuant to the Joint Stipulation, the three-judge panel conducted the arbitration hearing on March 7-9, 2017;


WHEREAS, the parties have agreed to amend the Joint Stipulation to extend the time to submit written arguments;

NOW THEREFORE, IT IS HEREBY STIPULATED AND AGREED, by and between the parties, as follows:

1. The parties may submit written arguments in memoranda not to exceed (thirty) 30 pages in length within twenty-one (21) calendar days following the conclusion of the arbitration hearing, through and including March 30, 2017.
2. The arbitration panel shall issue a reasoned decision applying West Virginia law within thirty (30) calendar days after the submission by the parties of written arguments, through and including April 29, 2017.
3. Except as amended by Paragraphs 1 and 2 above, the Joint Stipulation remains in full force and effect.

IT IS SO ORDERED.
