**STIPULATION FOR DISMISSAL**


Pursuant to Rule 41(A)(1) of the West Virginia Rules of Civil Procedure, it is hereby stipulated and agreed by Plaintiff and Counterclaim Defendant Crestwood Appalachia Pipeline, LLC ("Crestwood") and Defendant and Counterclaim Plaintiff Arsenal Resources LLC ("Arsenal") (f/k/a Mountaineer Keystone LLC) that all of the parties' claims that have been or could have been asserted in this litigation have been compromised and settled. All of Crestwood's claims should be dismissed without prejudice, and Arsenal's counterclaim should be dismissed with prejudice. Each party shall bear its own costs, expert witness fees, attorneys' fees, and any other expenses of litigation. This stipulation is signed by all parties who have


