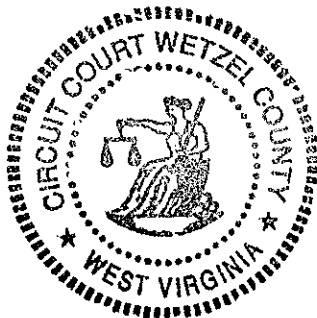
1. All responses to the Motion to Dismiss shall be filed by **October 12, 2018**;
