JOINT MOTION AND AGREED ORDER TO CONTINUE HEARING

Comes now Plaintiff, by and through counsel Robert P. Dunlap, II, Esquire and Eastern Electric, LLC, by and through counsel, John D. Hoblitzell, III and moves the Court to continue the hearing on pending motions scheduled for January 25, 2019. In support of said motion the parties aver as follows:

- 1) Defendant through counsel agrees to supplement discovery disclosures pursuant to the delineated requests from Plaintiff. Upon review of the supplemental discovery, if necessary, Plaintiff will communicate to Defendant the need for an additional meet and confer. If agreement cannot be reached the parties will then set a hearing for the pending motions.
- 2) Plaintiff concurs that based on this agreement it is premature to bring the pending motions related to discovery before the Court.
- 3) Plaintiff agrees to postpone the Motion for Leave of Court to File Second Amended Complaint in an effort to preserve judicial economy.
- 4) The parties seek additional time to resolve the pending discovery issues before proceeding to mediation and trial.


Upon mature consideration of the Court, the motion is **GRANTED**, and it is hereby **ORDERED** that the hearing on motions scheduled for January 25, 2019 at 2:00 pm in the Circuit Court of Nicholas County be continued to allow the parties to resolve pending discovery issues.

The Circuit Clerk is directed to mail copies of this Order all parties of record.


