BRIEFING ORDER ON PLAINTIFF'S MOTION TO COMPEL


IT APPEARING that the Plaintiff, BB Land, LLC, has filed a Motion to Compel, it is ORDERED pursuant to Rule 22 of the West Virginia Trial Court Rules as follows:

Non-moving parties shall file written responses within 15 days of the entry of this order, if desired, and serve copies of the same on the moving party. The movant may thereafter file rebuttal memoranda, if desired, within 10 calendar days of the filing of any response. Thereafter, the Court will regard the matter as ripe for consideration and will rule upon the motion on the pleadings and the record or set the matter for evidentiary or other hearing as the Court finds necessary.
