AGREED ORDER AMENDING BRIEFING SCHEDULE

ON A FORMER DAY, the Business Court established a deadline for the Property Tax Division to re-value the producing oil and gas wells which are on appeal for ad valorem property tax purposes and for the Parties to file dispositive motions in this matter.

The Property Tax Division has re-valued the wells at issue as directed by the Court; however, transmitting the re-valuations was delayed due to the Christmas and New Year's holidays.
