**AGREED ORDER  
AMENDING BRIEFING SCHEDULE**

---

ON A FORMER DAY, the Business Court established a deadline for the Property Tax Division to re-value the producing oil and gas wells which are on appeal for ad valorem property tax purposes and for the Parties to file dispositive motions in this matter.

The Property Tax Division has re-valued the wells at issue as directed by the Court; however, transmitting the re-valuations was delayed due to the Christmas and New Year's holidays. Furthermore, the Parties have technical questions regarding the re-valuations. The Parties are optimistic that they can resolve the technical questions regarding the re-valuations of the wells on appeal and that dispositive motions may not be necessary to resolve this matter.

Wherefore, the Parties have agreed to amend the deadline for filing dispositive motions in this matter to February 20, 2020 and the deadline to file replies to March 6, 2020.

The amended deadlines appear proper to the Court.


WHEREFORE, the deadline to file dispositive motions is extended to February 20, 2020, and the deadline to file replies to the dispositive motions is extended until March 6, 2020.

The Clerk of the Circuit Court is directed to transmit a true copy of this Order to the parties of record at the addresses listed below.




