ORDER REGARDING MAY 11, 2020, STATUS CONFERENCE

On May 11, 2020, the Court held a status conference in this action. For the reasons stated on the record, the Court hereby FINDS, CONCLUDES, and ORDERS as follows:

- 1) The State shall deliver to the Court the documents identified on the 11.13.18 State of West Virginia Privilege Log for in camera review by the Court.
- 2) The State shall produce any supplemental expert analysis no later than May 15, 2020, and Defendants shall produce any supplemental expert analysis no later than June 3, 2020. In the event a dispute arises as to additional depositions of expert witnesses, the parties shall notify the Court.
- 3) No later than May 21, 2020, the State shall inform counsel for WVP Defendants if the documents and records referred to in the letter dated May 4, 2020 are available and whether the State will produce those documents and records.
- 4) The Court will enter an Amended Scheduling Order that will include a deadline of June 17, 2020 for filing motions in limine with respect to experts and set a hearing on any such motions

for 10 a.m. on July 15, 2020. The Court has not yet determined whether the expert witnesses will be required to testify at the hearing.

5) The Court will hold another status conference on May 27, 2020, at 11:00 a.m. via teleconference.

The parties' objections and exceptions to this Order are noted and preserved.

The Clerk shall serve a certified copy of this Order to all parties of record.
