
1. Respondents may serve any additional legal memoranda regarding Petitioner's Motion on or before September 15, 2020.

3. On or before September 22, 2020, each party may submit proposed findings of fact and conclusions of law regarding Petitioner's Motion for the Business Court to consider.



The Clerk of the Court is hereby directed to transmit a true copy of this Order to the parties at the addresses listed below.


