## ORDER DENYING MOTION FOR PRELIMINARY INJUNCTION WITHOUT PREJUDICE

ON A FORMER DAY, Antero Resources Corporation, filed a motion for preliminary injunction asking the Business Court to suspend Antero Resources' obligation to pay ad valorem property taxes for the 2020 tax year.
