**ORDER GRANTING TH EXPLORATION, LLC'S
MOTION FOR LEAVE TO FILE UNDER SEAL**

On this 7th day of October, 2020, came defendant TH Exploration, LLC, by and through its counsel, K&L Gates LLP, and pursuant to West Virginia Rule of Civil Procedure 26(c)(8) and West Virginia Trial Court Rule 15.12, seeking leave to file (i) TH Exploration, LLC's Memorandum of Law in Support of its Motion for Partial Summary Judgment as to Plaintiffs' Declaratory Judgment and Breach of Contract Claims; (ii) Appendix in Support of TH Exploration, LLC's Motion for Partial Summary Judgment as to Plaintiffs' Declaratory Judgment and Breach of Contract Claims; and (iii) TH Exploration, LLC's Memorandum of Law in Support of its Motion for Partial Summary Judgment as to Plaintiffs' Tort Claims under seal.
