Justices Help State Bar Group Distribute Law Day Awards

CHARLESTON, W.Va. – On Monday, Chief Justice John Hutchison, Justice Beth Walker, Justice Tim Armstead, Justice William R. Wooton, and Justice C. Haley Bunn helped the West Virginia State Bar Women in the Profession Committee congratulate Law Day contest award winners. Chief Justice Hutchison also gave students a virtual tour of the Supreme Court Courtroom.

President Dwight D. Eisenhower founded Law Day in 1958 to celebrate the role of law in America. Law Day events are held on or near May 1. This year's Law Day theme is "Toward a More Perfect Union: The Constitution in Times of Change." The theme is set annually by the American Bar Association.

The Justices thanked the students and teachers who participated, saying the Constitution is the bedrock of the American justice system.

The West Virginia contest, which began last year, received a Law Day Outstanding Activity Award from the American Bar Association. The ABA recognized that the program "achieved broad outreach to the community and engaged target audiences in meaningful conversations to help foster understanding about the rule of law in our society" despite challenges presented by the COVID-19 pandemic.

The West Virginia State Bar Women in the Profession Committee is led by attorneys Jami Cooper and Lee Hall, while Circuit Judge Bridget Cohee, Twenty-Third Judicial Circuit (Berkeley, Jefferson, and Morgan Counties), led work on the Law Day program.

The committee asked students across the state to participate by submitting posters, essays, songs, poetry, and social media posts. There were 10 projects submitted by 26 elementary school students and 75 projects submitted by 103 middle school students. Six high school projects were submitted. Submissions were from Wheeling, Morgantown, Clarksburg, Buckhannon, Newburg, Barboursville, Inwood, Martinsburg, and Crab Orchard.

Prize packages and certificates were donated by the West Virginia State Bar and the Bar Associations of Monongalia and Harrison Counties, the Eastern Panhandle Bar Association, and ChildLaw Services, Inc. A list of the winners follows.
