FINAL ORDER

On the 3rd day of July, 2019, came the Defendants¹, by counsel, Joseph L. Jenkins, Lewis Glasser PLLC, and David C. Hook, Hook & Hook; and Plaintiff, by counsel, Eric M. Gordon, Berry, Kessler, Crutchfield, Taylor & Gordon, for a hearing on Defendants' motion for further proceedings to determine just compensation. After reviewing Defendants' motion and the records of this matter, the Court hereby **DENIES** Defendants' motion.

The Plaintiff filed this condemnation action on June 1, 1990 to acquire two parcels, including "all of the oil and gas appurtenant thereto," owned by the Defendants in Marshall County, West Virginia as further described in more detail in the Plaintiff's Petition. A hearing was held on June 15, 1990, whereby, over the Defendants' objections, the Court entered an Order on the same date granting the Plaintiff right of entry and vesting it with defeasible title to the property it sought to condemn.

¹Orange and Margaret Scherich are deceased. Their grandson, Eugene Scherich, along with the other defendants, their son and his wife, Thomas and Bertha Scherich, are the current owners of the property sought to be condemned in this matter and filed the motion for further proceedings.

On June 15, 1990, the Plaintiff, pursuant to W. Va. Code § 54-2-14a, paid into this Court the sum of \$97,000.00 as its estimate of just compensation for the property sought to be condemned. The last activity in this matter was an order entered on May 30, 1991 disbursing the Plaintiff's deposit of \$97,000.00 to the Defendants.

Given the time between the filing of Defendants' motion for further proceedings and the last activity in this matter – a period of over twenty-seven years – the Court FINDS that this matter has been concluded; and that any claims of deficiency in the due process afforded the Defendant landowners were waived by Defendants. Furthermore, the doctrines of estoppel and laches, as well as potentially any statutes of limitation or repose, prevent Defendants from resurrecting this matter. Finally, the Court believes the acceptance of the deposited funds, as evidenced by the last order entered in this matter on May 30, 1991 disbursing such funds to Defendants, without further proceedings until now, is sufficient proof of accord and satisfaction such that Defendants have no further right or claim in this matter.

Accordingly, for the above reasons, the Court DENIES Defendants' motion and ADJUDGES that this matter was concluded as of the last activity on record: May 30, 1991.

Additionally, at the hearing, counsel for Plaintiff, Eric M. Gordon, discovered that a former partner in his firm, Rodney T. Berry, had previously represented Defendants in this matter. Upon discovering the potential conflict, Mr. Gordon, without objection from the Plaintiff, represented at the hearing by its President, Howard Coffield, moved to withdraw his representation of Plaintiff. Finding the motion appropriate under the circumstances and having no objection from the Plaintiff, the Court GRANTS Mr. Gordon's motion to withdraw from the representation of Plaintiff.
