SENTENCING ORDER

On the 21st day of April, 2021 came the State of West Virginia in the above-styled action by Micheal M. Cochrane, Prosecuting Attorney and came the Defendant, Candice T. Salmons, individually and by her counsel, Thomas H. Evans, III pursuant to this matter having been scheduled for hearing on sentencing this date.

WHEREUPON, it was represented to the Court by respective counsel for the State and the Defendant as follows:

 That the Defendant was found guilty by a jury composed of twelve (12) competent jurors on June 19th, 2019 to one count of Grand Larceny, in violation of West Virginia Code 61-3-13(a), one count of Conspiracy to Commit a Felony, in violation of West Virginia Code 61-10-31 and one count of Nighttime Burglary, in violation of West Virginia Code 61-3-11.

A pre-sentence investigation was conducted by the
 Probation Department and a copy was provided to the Court,
 State and Defense Counsel.

On this date, the Court inquired of the Defendant as to whether she had anything to say before pronouncement of sentence upon her, to which the Defendant responded in a manner as contained in the report of the proceedings herein.

"Ms. Salmons, in accordance with your conviction in this Court to the charges of Grand Larceny this Court sentences you to confinement in the Division of Corrections for one term of not less than one nor more than ten years, to the charge of Conspiracy to commit a Felony this Court sentences you to confinement in the Division of Corrections for one term of not less than one nor more than five years and to the charge of Nighttime Burglary this Court sentences you to confinement in the Division of Corrections for one term of not less than one nor more than fifteen years. Sentences are to run concurrently. You will be given credit for 2 days time served. Costs will be assessed. You are hereby ordered to the custody of the Division of Corrections today."
