## ORDER DISMISSING GLADE SPRINGS VILLAGE PROPERTY OWNERS ASSOCIATION, INC.'S MOTION FOR PARTIAL SUMMARY JUDGMENT ON COUNT XI BREACH OF REPRESENTATION TO GIVE COVENANT OF SPECIAL WARRANTY COVENANT FOR WOODHAVEN

Pending before the Court is Plaintiff's Glade Springs Village Property Owners Association, Inc.'s Motion for and Memorandum in Support of Partial Summary Judgment on Count XI Breach of Representation to Give Covenant of Special Warranty Covenant for Woodhaven.

The Parties have fully briefed the issues necessary. The Court dispenses with oral argument because the facts and legal contentions are adequately presented in the materials before the Court and argument would not aid the decisional process.

The Court, having considered the pleadings, evidence, written submissions of the parties and arguments of counsel, **FINDS** that On July 20, 2023, the Court granted Cooper Land Development's (hereinafter "CLD") *Motion for Summary Judgment on Statute of Limitations* and dismissed all claims against CLD with prejudice. Therefore, the Court finds that this *Motion* as to CLD is moot.

As to Defendant Justice Holdings, Plaintiff Glade Springs Village Property Owners Association proffered in its Corrected Glade Springs Village Property Owners Association, Inc.'s Joint Response in Opposition to Cooper Land Development, Inc.'s Motion for Summary Judgment and Justice Holdings LLC's Motions for Summary Judgment and Motion to Dismiss Counts III, X and XI that it did not oppose Justice Holdings' crossmotion to dismiss Justice Holdings from Count XI.

Therefore, this Court **DISMISSES** Plaintiff's *Glade Springs Village Property*Owners Association, Inc.'s Motion for and Memorandum in Support of Partial Summary

Judgment on Count IX Breach of Representation to Give Covenant of Special Warranty

Covenant for Woodhaven and **ORDERS** that Count XI of Plaintiff's Complaint be dismissed.
