### Two Circuit Judges to Hear Arguments in an ICA Case

CHARLESTON, W.Va. – Two circuit judges will hear arguments in an Intermediate Court of Appeals of West Virginia (ICA) case on Wednesday, May 22.

Thirteenth Judicial Circuit Judge Maryclaire Akers was appointed to fill in for Chief ICA Judge Thomas E. Scarr and Second Judicial Circuit (Marshall, Tyler, and Wetzel Counties) Judge C. Richard Wilson was appointed to fill in for ICA Judge Charles O. Lorensen. Judges Scarr and Lorensen voluntarily recused themselves.

The Rule 19 Argument in *Barry Barr v. Brent Jackson, Lynn Perkins, Hedgesville Real Estate, LLC, VIP Gentlemen's Club LLC d/b/a Lust Gentlemen's Club, and West Virginia Sports Promotions, Inc.*, No. 23-ICA-337, will be heard at 10 a.m. in the ICA Courtroom in the West Virginia Judicial Tower, 4700 MacCorkle Avenue, SE.

Cases set for Rule 19 arguments involve assignments of error in the application of settled law; claims of an unsustainable exercise of discretion where the law governing that discretion is settled; claims of insufficient evidence or a result against the weight of the evidence; and cases involving a narrow issue of law or in which a hearing is required by law.
