The issues were tried before the Court and jury on April 2, 2019. At the conclusion of all of the evidence and after hearing the instructions of the Court and the argument of counsel, the jury retired to their chambers to consider the verdict as to the Parties to this action, and after some time, returned to the Court and upon their oaths presented their verdict as stated below:

"VERDICT FORM

1.	We, the Jury, find by a preponderance of the evidence, that the Plaintiffs' compensatory and general damages are as follows:
	Plaintiff Joe Jenkins' Medical Expenses \$ 2,970.00
	Lost Wages of Plaintiff Joe Jenkins \$ 600.00
	Damages for loss of use of Plaintiffs' automobile \$ 33,358.98
	Aggravation and inconvenience \$ 12,000.00
	Loss of consortium of Stephanie Jenkins \$ 8,000.00
	TOTAL \$ 56,928.98

Accordingly, it is **ADJUDGED** and **ORDERED** that the Plaintiffs, recover from the Defendants, Tessa Ann Jordan and Lynn Jordan, jointly and severally, as compensatory and general damages, the sum of \$56,928.98 with pre-judgment interest of \$2,431.24 on the liquidated damages

of \$36,928.98, calculated at the legal rate of 4.5% per annum on those liquidated damages specified on the Jury Verdict Form, which results in a total judgement of \$59,360.22 which judgement bears post-judgement interest of \$7.32 per day, from and including April 3, 2019 until paid.

It is further ADJUDGED and ORDERED that the Plaintiffs will recover their costs from the Defendants as taxable and assessed under the law of this State and Plaintiffs should provide to the Circuit Clerk a Bill of Costs within 10 days after the entry of this Judgment Order. The Defendants are also ORDERED to pay all costs as assessed by the Clerk as a matter of law for this jury trial.

The objections and exceptions of the Defendants to this Judgment Order are noted herein.
