**ORDER FOR THE APRIL 14, 2020
SCHEDULING CONFERENCE**

On April 14, 2020, a telephonic scheduling conference was held to set prehearing and hearing dates for the above-named case. Rachael L. 
On or about March 22, 2020, the Chief Justice of the Supreme Court of Appeals of West Virginia, in response to the Covid-19 crisis, declared a judicial emergency pursuant to Article 8, Section 3 of the Constitution of West Virginia. As a result, an Order was entered continuing all judicial deadlines to April 10, 2020. Thereafter, on or about April 3, 2020, an Amended Order was entered continuing all judicial deadlines to May 1, 2020. Accordingly,

the Chairperson Haught directed that the deadlines for this matter be calculated from the date of May 1, 2020.

Accordingly, the Hearing Panel Subcommittee **ORDERS** as follows:


1. That Disciplinary Counsel's discovery shall be provided on or before May 21, 2020;
2. That Respondent's answer to the Statement of Charges is due on or before June 1, 2020;
3. That Respondent's discovery shall be provided on or before June 22, 2020;
4. That all motions shall be filed on or before July 10, 2020;
5. That all responses to motions shall be filed on or before July 17, 2020;
6. That the exhibit notebooks shall be provided to all parties on or before July 17, 2020;
7. That the telephonic prehearing in this matter will be held at 10:00 a.m. on July 20, 2020; and
8. The hearing in this matter will be held at 9:00 a.m. on August 11-12, 2020, at the Harrison County Courthouse, County Commission Meeting Room, 301 West Main Street, 3rd Floor, Clarksburg, West Virginia.
