ORDER OF CERTIFICATION

EVAN JENKINS, Chief Justice:

The Honorable Susan B. Tucker, Division 1 of the 17th Judicial Circuit of the State of West Virginia, pursuant to WEST VIRGINIA CODE §58-5-2, respectfully requests that the Supreme Court of Appeals of West Virginia (“Supreme Court”) exercise its discretion to answer the following question:

- 1) Whether a jury’s failure to unanimously decide the recommendation of mercy allows the Circuit Court to impose the life sentenced required for a conviction of First Degree Murder pursuant to WEST VIRGINIA CODE §61-2-2 and either grant mercy or decline to grant mercy?

Answer: Yes.

It is this Court’s opinion that there is no controlling appellate decision, constitutional provision, or statute delineated in the WEST VIRGINIA CODE that answers this question. Accordingly, this Court concludes that the question is appropriate for certification under WEST VIRGINIA CODE §58-5-2.

STATEMENT OF FACTS AND PROCEDURAL HISTORY

On June 18, 2020, the Grand Jurors of the State of West Virginia, in and for the citizens of Monongalia County, upon their oaths, charged Shaundarius Reeder (“Mr. Reeder” or “Defendant”) with Murder in the First Degree pursuant to WEST VIRGINIA CODE §61-2-1 and Conspiracy to Commit Murder pursuant to WEST VIRGINIA CODE §61-10-31.

The case arises out of actions that occurred on February 28, 2020 in Morgantown, Monongalia County, West Virginia. On Tuesday, June 8, 2021, the undersigned empaneled a jury to hear the case to be tried between the State of West Virginia and Mr. Reeder. After the State of West Virginia and Defendant presented their respective cases and this Court instructed the jury as to the applicable laws and rules governing deliberation, on Thursday, June 10, 2021, the jury returned a unanimous verdict of Guilty as to Count One, Murder in the First Degree, and Guilty as to Count Two, Conspiracy to Commit Murder as charged in the Indictment against Mr. Reeder.

On May 28, 2021, prior to the commencement of the trial, counsel for Defendant submitted Defendant's Motion to Bifurcate Determination of Mercy from the Trial ("Motion"). The State of West Virginia did not oppose the Motion and the undersigned granted the same. Therefore, on Friday, June 11, 2021, the jury returned to begin the mercy phase of the trial. The Defendant presented his evidence followed by the State of West Virginia. The undersigned instructed the jury as to the applicable law, counsel of record presented closing arguments, and the jury began deliberation regarding the determination of mercy.

Thereafter, it was apparent that the jury was having difficulty in reaching a decision given the two (2) questions submitted to the undersigned. That evening, upon the jury's request, the undersigned recessed, and the jury returned on Monday, June 14, 2021 to resume deliberations. That same day, the jury informed the Court that it was unable to come to a unanimous verdict after approximately twelve (12) hours of deliberation. Because the Court had previously instructed the jury as to their duty in accordance with *State vs. Blessing*, 331 S.E.2d 863 (1985), the undersigned found it appropriate to dismiss the jury.

At this juncture, the Defendant stands convicted of the crimes of Murder in the First Degree and Conspiracy to Commit Murder as charged in the Indictment. The undersigned has not yet set a hearing on Post-Trial Motions and/or Sentencing pending the instant submission to this Court.

ANALYSIS

WEST VIRGINIA CODE §62-3-15 was enacted during the 1994 legislative session. To date, although this Court has had the opportunity to interpret specific questions related to the statute, for example bifurcation and instructions, it has not addressed the precise issue at hand.

The certified question aims to determine the course of procedure when the Court encounters a hung jury in the mercy phase of a bifurcated First Degree Murder trial. It is well settled that a jury verdict regarding the granting or refusal to grant mercy must be unanimous. *See State v. McLaughlin*, 700 S.E.2d 289 (W. Va. 2010). Additionally, it is clear that if a jury cannot make a determination regarding mercy, that does not affect the conviction of guilt. *See State v. Doman*, 512 S.E.2d 211 (W. Va. 1998); *see also Lister v. Ballard*, 784 S.E.2d 733 (W. Va. 2016) (stating that the issue of mercy in a bifurcated trial is whether or not a defendant who has already been found guilty should be afforded mercy.). However, there is a gap in West Virginia law about how a Circuit Court must proceed when a jury is unable to reach a verdict in the mercy phase of the trial.

The Supreme Court has ruled that the sentencing court is given broad discretion in imposing a sentence if it is within the statutory limits and not based on an impermissible factor. *See State vs. Broughton*, 470 S.E.2d 413 (W. Va. 1996). The Supreme Court has also stated that the First Degree Murder Statute leaves “very little sentencing discretion to juries” because a finding of guilt “*automatically* results in a life sentence and a jury’s only discretion

is whether to grant parole eligibility by recommending mercy.” *See State ex rel. Leach v. Hamilton*, 280 S.E.2d 62 (W. Va. 1980) (emphasis added).

There are cases where a defendant takes a plea to First Degree Murder. In those instances, the Circuit Court imposes a sentence and determines the attachment of mercy based on the facts and circumstances presented. In the situation at hand, the Circuit Court presided over the mercy phase of the trial and therefore knows the facts and circumstances presented and, arguments thereto, that counsel presented to the jury. Accordingly, the Circuit Court is able to make a qualified determination regarding mercy just like the jury had the opportunity to do at trial.

Given the above coupled with the fact that West Virginia law regarding the sentence for First Degree Murder is unambiguous and requires “confinement in the penitentiary for life,” it is the undersigned’s position that absent a unanimous recommendation of mercy, it is appropriate for the Circuit Court to impose the statutory sentence for First Degree Murder and determine whether or not to grant mercy. *See WEST VIRGINIA CODE §61-2-2*

This Court acknowledges that the Supreme Court of Appeals of West Virginia may reformulate this question pursuant to WEST VIRGINIA CODE §58-5-2.

Accordingly, pursuant to WEST VIRGINIA CODE §58-5-2 and Rule 17(a) of the *West Virginia Rules of Appellate Procedure*, it is hereby **ORDERED** that this action is stayed until such question has been decided and the decision thereof certified back to this Court. The parties are **DIRECTED** to prepare a joint appendix of the record sufficient to permit review of the certified question.

Therefore, it is further **ORDERED** (1) that the question stated above be, and the same hereby is, certified to the Supreme Court of Appeals of West Virginia, and (2) that the Clerk of this Court forward to the Supreme Court of Appeals of West Virginia, under the official seal of this Court, a copy of this Order.




