**ORDER GRANTING QUALIFIED SETTLEMENT FUND
ADMINISTRATOR'S MOTION AND RECOMMENDATIONS
FOR 2024 DISTRIBUTION OF OPIOID ABATEMENT FUNDS**

Now pending before the Court is the *Qualified Settlement Fund Administrator's Motion and Recommendations for 2024 Distribution of Opioid Abatement Funds* (Transaction ID 75147457) filed December 5, 2024. The Court has reviewed the motion, the Qualified Settlement Fund Administrator's recommendations, and Exhibit 1 to the motion. There being no objection to the motion and finding good cause shown, the Court **GRANTS** the motion recommending that One Hundred Million Dollars (\$100,000,000.00) be distributed for the 2024 calendar year in accordance with the West Virginia First Memorandum of Understanding, which provides the following allocations:

1. 24.5% (\$24,500,000.00) to Local Governments, with each Local Government share consistent with the allocations in Amended Exhibit C filed on September 29, 2023.¹
2. 72.5% (\$72,500,000.00) to the West Virginia First Foundation.
3. 3% (\$3,000,000.00) to the State of West Virginia.

It is, therefore, **ORDERED** that Fund Administrator John Jenkins shall distribute One Hundred Million Dollars (\$100,000,000.00) to the Local Governments, the West Virginia First Foundation, and the State of West Virginia in accordance with the West Virginia First Memorandum of Understanding and Amended Exhibit C filed on September 29, 2023, as specifically as set forth in Exhibit 1 attached to this Order.
