# 2024 Annual Report of the Mass Litigation Panel

## **Asbestos Personal Injury Litigation**

In 2024, Judge Ronald E. Wilson scheduled 3 trial groups, consisting of approximately 60 Asbestos Personal Injury cases – living and deceased mesothelioma cases and living lung cancer cases – and 60 Backlog Lung Cancer cases, for a total of 120 cases scheduled for trial in February, June, and October 2024. Although most of the cases were resolved before trial, a small number of cases were moved to future trial groups. 108,552 documents were filed, and 4,525 orders were entered in the Asbestos Personal Injury Litigation in 2024.

#### **FELA Asbestos Cases**

6 FELA Asbestos cases are currently pending: 3 cases filed in 2020; 1 case filed in 2022; and 2 cases filed in 2023. 4 cases were dismissed in 2024 as fully compromised and settled. Judge Gregory L. Howard, Jr. conducted status conferences in the 6 pending cases on January 27, 2025, scheduled oral argument on dispositive motions in 3 cases, scheduled trial dates in 2 cases, and scheduled another status conference in 1 case.

### **Mingo County Coal Slurry Litigation**

Judge Gregory L. Howard, Jr. continues to monitor the Mingo County Coal Slurry Litigation Medical Monitoring Program's Irrevocable Medical Care Trust.

# **Opioid Litigation**

All matters in controversy between all Plaintiffs and all Defendants have been resolved. The NAS cases were dismissed, with prejudice, subject to appeal, by Orders entered May 31, 2023,<sup>4</sup> and June 27, 2023,<sup>5</sup> pursuant to motions to dismiss filed by all Defendants. Plaintiffs filed Notices of Appeal to the Intermediate Court of Appeals on June 29, 2023,<sup>6</sup> June 30, 2023,<sup>7</sup> and July 14, 2023.<sup>8</sup> The

ICA heard oral argument under Rule 20 on September 17, 2024, as part of ICA On-Campus. On December 27, 2024, the ICA issued an opinion affirming in part, reversing in part, vacating in part, and remanding the NAS cases for further proceedings consistent with the ICA's opinion.

On March 7, 2024, the Panel ordered *State of West Virginia v. Publicis Health, LLC*, Civil Action No. CC-40-2024-C-20 transferred to Panel and joined with the Opioid Litigation (Transaction ID 72298093). The final consent judgment/consent order was entered in that case on March 19, 2024 (Transaction ID 72555495).

The State and Local Governments have entered into the West Virginia First Memorandum of Understanding ("MOU")<sup>10</sup> regarding the division of monetary amounts obtained through settlement or judgment, which has been adopted by the Court.<sup>11</sup> According to the terms of the MOU, 72.5 % will be distributed to the West Virginia First Foundation, which has been incorporated and approved by the West Virginia Legislature,<sup>12</sup> and 24.5 % will be paid to the Local Governments and divided pursuant to a formula agreed to by all parties. The remaining 3% will be held in escrow by the State for expenses incurred related to opioid litigation. If the 3% is not spent by December 31, 2026, then 1% goes to the Local Governments and 2% goes to the West Virginia First Foundation.<sup>13</sup>

A qualified settlement fund has been established, a Fund Administrator has been appointed, and a banking institution has been designated in which settlement funds will be deposited.<sup>14</sup> The Presiding Judges review the quarterly reports for the West Virginia First Qualified Settlement Fund, jointly filed by the Fund Administrator and the Custodial Bank and enter orders regarding payment of administrative costs.<sup>15</sup>

In 2024, the Presiding Judges also entered orders addressing MDL 2804 Common Benefit payments, <sup>16</sup> reimbursement of litigation held expenses and distribution of attorney fees, <sup>17</sup> and the
