ORDER

This matter came before the Court this 30th day of April, 2025. The Defendant and Third-Party Plaintiff, WW Consultants, Inc., (hereinafter "WWC" or "Defendant"), by counsel, has filed WW Consultants, Inc.'s Motion for Partial Summary Judgment on Plaintiff's Claim for Damages on April 29, 2025. Further, the Plaintiff, the Pocahontas County Public Service District (hereinafter "Plaintiff" or "the PSD"), by counsel, has filed Plaintiff's Motion for Partial Summary Judgment for Count II Paragraph 61, Subparts (A) Through (D) of Plaintiff's Complaint on April 28, 2025.

On January 23, 2025, an Order Granting Joint Motion to Modify Discovery and Dispositive Motion Deadlines was entered, establishing a dispositive motions deadline and briefing schedule as follows:

THE COURT, having considered the Parties' Motion, hereby ORDERS as follows:

1. The deadline for the Completion of Depositions is extended to March 3, 2025;

2. The deadline for the filing of dispositive motions is hereby amended to March 17, 2025;

3. Any responses shall be filed by March 31, 2025;

4. Any replies shall be due on April 7, 2025.

See Ord., 1/23/25, p. 2.

The Court notes that on February 25, 2025, an Order Granting WW Consultants, Inc.'s Motion for Protective Order and to Amend Deadlines was entered, in which due to the rescheduling of certain depositions, the deadline for completing remaining depositions was continued until April 15, 2025, and the dispositive motions deadline was extended to fourteen days after that. *See* Ord., 2/25/25, p. 2.

This Order did not address the due dates for the responses and replies. To clarify, the Court ORDERS as follows:

- 1. Any responses to dispositive motions shall be filed by May 16, 2025.
- 2. Any replies shall be due on May 28, 2025.

The Court directs the Clerk to distribute attested copies of this Order to all counsel of record and to the Business Court Central Office, electronically.
