Starting Salary Range: \$40,000-45,000

Position Summary: The Parent Resource Navigator (PRN) Development Coordinator will oversee, organize, and review operational activities for the WV Court Improvement Program Parent Resource Navigator Program. The PRN Development Coordinator will promote and convey the overall vision and direction for the program, effectively outline the program's strategy, objectives, requirements, and goals. In addition, will bring about various program initiatives and activities, assist with guidance and instruction on how PRN's can achieve overall strategies to reach the program's goals and desired outcomes. This is an ideal position for individuals passionate about making a positive impact on the lives of children and families while navigating abuse and neglect cases.

Essential Position Duties and Responsibilities:

- Assist the CIP Youth Project Manager by overseeing operational aspects of the program. Assist with onboarding, implementation, development, and ongoing oversight of established PRN's.
- Provide program direction/expectations, monitor operational progress, and provide quality assurance regarding the services and activities provided.
- Establish milestones, monitor adherence to ICAN application and timeframes while seeking opportunities to make improvements to program efficiency and process.
- Ensure all required information and corresponding documentation is being completed and retained properly.
- Confirm record keeping is accurate and organized by reviewing available information.
- Observe each PRN and ensure they are consistent with the model and the long-term goals and objectives of the program.

- Consistently provide support, guidance, and role modeling to all members. Be available and responsive to the needs of the PRN as they arise. In addition to being onsite as needed, a minimum of two PRN's will be visited each month.
- Conduct program audits, prepare reports and document findings and recommendations. Conduct follow-up audits as required. Evaluate internal controls to ensure the effective management of risks and protection of assets. Evaluate performance and activities, ensuring alignment with the strategic plan, goals, and objectives of the program grant.
- Participate in and/or conduct training, coordinate meetings, attend workshops and conferences as required.
- Other additional duties as assigned

- Minimum of an Associate's Degree in social services, education, psychology, counseling or related field.
- Valid Driver's License and reliable transportation with required insurance.
