PLAINTIFF'S RESPONSE TO DEFENDANTS' MOTION FOR LEAVE TO FILE A RESPONSE TO PLAINTIFF'S REPLY IN OPPOSITION TO MOTION TO REFER CASE TO THE BUSINESS COURT DIVISION

Plaintiff Linda Propst ("Plaintiff"), by and through her undersigned attorneys, hereby states as follows:

- 1. With respect to the above referenced Jefferson County litigation, the Defendants filed a motion to refer this matter to the Business Court Division on or about April 5, 2022.
 - 2. The Plaintiff filed a reply in opposition on or about April 12, 2022.
- 3. Under Trial Court Rule 29.06(a), that should have been it. The Rule contemplates only those two filings: a motion and a response to that motion (which is called a "reply" under the rule). There is no provision for a rebuttal by the moving party. Therefore, the non-moving party is supposed to get the last word.
- 4. Nevertheless, on April 26, 2022 the Defendants filed a motion for leave to file a response to the Plaintiff's reply.

5. The Plaintiff opposes the transfer of this case to the Business Court Division for the reasons already stated: this is not a Business Court case. While a defunct business is nominally involved, the main allegations are by individuals against individuals. Moreover, the familiar fraud and breach of fiduciary duty allegations which lie at the heart of this case are nothing like the complex business disputes for which Business Court was created.

6. However, to the extent that this Honorable Court wishes to review further briefing on this subject, the Plaintiff does not object to the Defendants' request for leave to file a response.

7. But if the Court does permit the additional response brief requested by the Defendants, the Plaintiffs respectfully ask for the chance to file a short reply brief, if they believe it is necessary, within five (5) business days of receipt of Defendants' filing. This would allow the Defendants to have their say while still complying with the spirit of the applicable rule which entitles the non-moving party to have the final reply.
