#### ORDER GRANTING QUALIFIED SETTLEMENT FUND ADMINISTRATOR'S MOTION AND RECOMMENDATIONS FOR 2025 DISTRIBUTION OF OPIOID ABATEMENT FUNDS

Now pending before the Court is the *Qualified Settlement Fund Administrator's Motion* and Recommendations for 2025 Distribution of Opioid Abatement Funds (Transaction ID 76822435) filed August 7, 2025. The Court has reviewed the motion, the Qualified Settlement Fund Administrator's recommendations, and Exhibit 1 to the motion. There being no objection to the motion and finding good cause shown, the Court **GRANTS** the motion recommending that Fifty Million Dollars (\$50,000,000.00) be distributed for the 2025 calendar year in accordance with the West Virginia First Memorandum of Understanding, which provides the following allocations:

- 1. 24.5% (\$12,250,000.00) to Local Governments, with each Local Government share consistent with the allocations in Amended Exhibit C filed on September 29, 2023.<sup>1</sup>
- 2. 72.5% (\$36,250,000.00) to the West Virginia First Foundation.
- 3. 3% (\$1,500,000.00) to the State of West Virginia.

It is, therefore, **ORDERED** that Fund Administrator John Jenkins shall distribute Fifty Million Dollars (\$50,000,000.00) to the Local Governments, the West Virginia First Foundation, and the State of West Virginia in accordance with the West Virginia First Memorandum of Understanding and Amended Exhibit C filed on September 29, 2023, as specifically as set forth in Exhibit 1 attached to this Order.
