ABOUT FTC

The West Virginia Family Treatment Courts (FTC) are a cooperative effort of the Circuit Court, Child Protective Services, substance use treatment providers, and other professionals involved in the welfare of children in the foster care system. These courts are a proven, evidence-based intervention designed to break the cycle of parental substance use disorder and child welfare involvement. FTCs integrate judicial oversight, structured treatment, and family-centered support services to help parents achieve long-term recovery while working toward the safe reunification of their children.

ELIGIBILITY

Participants in FTC are individuals involved in active child abuse/neglect (JA) proceedings in Circuit Court, adjudicated an abusing/ neglectful parent, granted a post-adjudicatory improvement period, and met the clinical criteria for a substance use disorder.

GUIDE PARENTS TOWARD RECOVERY

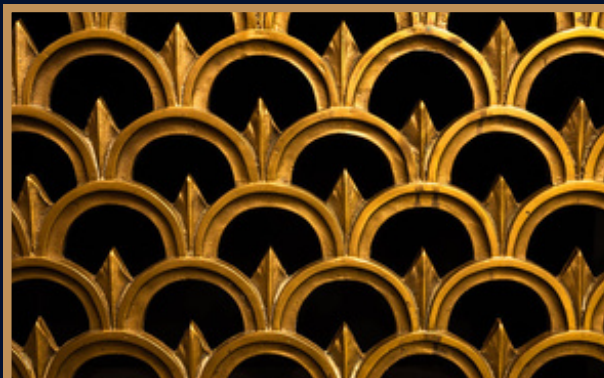
Through timely treatment & around the clock support, FTC helps parents begin their road to recovery & make lasting changes to enhance their lives.
