SENTENCING ORDER

On this the 7th day of August, 2023, came the defendant in person and by counsel, Tanner Wall , and also came the State of West Virginia by Teresa M. Samuels, Assistant Prosecuting torney, Cabell County, and Tyler Shoub, Assistant Prosecuting Attorney, Cabell County, West rginia, for sentencing pursuant to the defendant having previously been found guilty to the ony offense of “Malicious Assault” as contained in Count I of Indictment No. 22-F-234, guilty the Felony offense of “Use of Presentment of a Firearm during the Commission of a Felony” contained in Count II of Indictment No. 22-F-234, guilty of the Misdemeanor offense of omestic Battery” as contained in Count III of Indictment No. 22-F-234, guilty to the Felony ense of “Wanton Endangerment” as contained in Count V of Indictment No. 22-F-234, and ilty to the Felony offense of “Person’s Prohibited from Possessing a Firearm” as contained in unt VI of Indictment No. 22-F-234.

Whereupon, Counsel for the defendant, moved this Honorable Court for a New Trial, er hearing representations of Counsel, the Court was of the opinion to DENY the defendant’s otion for a New Trial.

Upon addressing counsel for the defendant, the Court determined that the defendant and counsel have had the opportunity to participate in the presentence investigation and have read d discussed the report thereof made available to them pursuant to Rule 32(b) of the West rginia Rules of Criminal Procedure. Further, the Court determined that there are no unresolved jections to said presentence report.

the defendant and addressed the defendant personally and asked him if he wished to make a statement in his own behalf and/or to present any information in mitigation of punishment.

Thereafter, the Court then demanded of the said Randy C Cain if he had or knew anything to say why the Court should not proceed to pronounce the sentence of the law against him, and nothing being offered or alleged in delay of judgment, it is ORDERED that the defendant be committed to the custody of the Division of Corrections for a period of not less than two (2) nor more than ten (10) years on Count I of Indictment No. 22-F-234, pursuant to West Virginia Code § 61-11-18 Recidivist Enhancement, the defendant's said sentence is enhanced to a period of not less than four (4) nor more than (10) years on Count I of Indictment No. 22-F-234, the defendant be committed to the Division of Corrections for a period of six (6) years on Count II of Indictment No. 22-F-234, said sentences for Count I and II of Indictment No. 22-F-234 shall run consecutive. The Defendant shall be committed to the custody of the Western Regional Jail for a period of twelve (12) months for Count III of Indictment No. 22-F-234, said sentence for Count III of said Indictment shall run concurrent to said sentence of Count II of Indictment No. 22-F-234. The Defendant shall be committed to the custody of the Division of Corrections for a period of three (3) years for Count V of Indictment No. 22-F-234, and to the custody of the Division of Corrections for a period of three (3) years on Count VI of Indictment No. 22-F-234, said sentences for Counts V and VI of Indictment No. 22-F-234 are to run concurrent with each other but are to run consecutive to Counts I and II of Indictment No. 22-F-234. The Defendant shall receive credit for time served in jail and on Home Confinement.

It appearing to the Court that the bond previously posted in this matter is no longer required, it is hereby ORDERED that the Clerk of the Circuit Court deduct from said bond any court ordered fines and court costs and return the remainder of said cash bond to the surety. In the event that a property bond was posted in this matter, upon discharge and release of said bond,


