- ✓ New Attorneys: must complete a total of 8 training hours. Of those 8 hours, 4 hours must include **Child Abuse and Neglect Mandatory Trainings**.
- ✓ Returning Attorneys: 8 hours of training is required every 2 years and can be completed through Lunch and Learns, Handle with Care Conference, or links provided by Kandi Greter.
- ✓ Complete the Child Abuse and Neglect Attorney Application form (Please include all counties you wish to serve).
- ✓ Complete the Educational Requirement Statement of Completion.
- ✓ Once submitted, your name will be placed on our Complete Child Abuse and Neglect Attorney list that will include: your name, phone number, and email address.
- ✓ **It is your responsibility to contact all Judges of the counties you wish to serve.** If they have any questions, they will contact Kandi Greter and she will let them know you have completed the training.
- ✓ Any time information changes or you would like to be removed from the list, please submit that information to Kandi Greter and she will update the information.
